TERMS & CONDITIONS OF MEMBERSHIP AGREEMENT

- 1. I/We acknowledge that on signature of this contract I/we will be liable to pay Synergy Business Club the following fees:-
 - 1.1. Company registration fees;
 - 1.2. Monthly membership fees paid monthly in advance;
